### Notes & Procedures

Kennel Name Registration Fee is \$25 for a 5 year period

THE ABOVE APPLICATION DOES NOT GUARANTEE THE REGISTRATION OF A KENNEL NAME. The Kennel Name is registered at the discretion of the Pudelpointer Club of North America. No more than two individuals can apply for a Registered Kennel Name. All new PCNA Kennel Name Applications are published in the next issue of Pudelpointer Points. If no objections are received by the secretary within 30 days following publication of the Kennel Name Application, the Kennel Name will be officially recognized and protected.

The Primary Applicant, and Co-Applicant (if any) must be PCNA member(s) in good standing

PCNA Kennel Names will be maintained as long as the Applicants remain as PCNA Members in good standing. Lapsed Kennel Name registrations may be reinstated within 60 days of expiration with a \$25 renewal fee, provided that the Kennel Name was not applied for during the expiration period. After 60 days, a new application is required. A registered kennel name is protected as both the first and last word.

Kennel names may be used as a Prefix or Suffix to a dog's name. A Kennel Name MUST be reflected in the name of all dogs registered by the user of a kennel name.

PCNA will not knowingly approve this application if the name applied for is a) A name now used by a breeder other than the applicant. b) A name considered by the Breeding Committee to be phonetically identical to a name already registered with PCNA. c) In the opinion of the Breeding Committee to be misleading, confusing or unsuitable as a kennel name.

Completed Kennel Name Applications should be submitted with the registration fee to the Club Secretary
