This contract is binding to anybody who is registered as the owner of said Pudelpointer.*

The contract conditions are as follows. The above named Pudelpointer **CANNOT**

1. Be used for breeding intentionally, or unintentionally, by the owner or any other party, without the written permission of the breeding committee of the Pudelpointer Club of North America (PCNA). All progeny of unintentional breeding will be neutered, spayed or euthanized by a licensed veterinarian.
2. Be spayed, neutered, sold or given away without the written permission of the breeder or breeding committee
3. Be registered with any studbook or registration other than the studbook of the PCNA
4. Be registered under any other name than the one listed above.
5. The above named Pudelpointer **MUST** be hip X-Ray evaluated (OFA or Penn) through a qualified veterinary service prior to age 30 months. A copy of the Hip evaluation must be forwarded to the PCNA Studbook keeper.
6. If any of the conditions agreed to in this contract are violated, the present owner will pay, upon demand, to the Pudelpointer Club of North America (PCNA) the sum of ten thousand dollars (\$10,000.00)
7. Should said breeder incur any expenses, which might include reasonable attorney's fees, in association with any action initiated by either party by reason of any dispute under this contract, said breeder shall be entitled to recover all his reasonable expenses from said owner.
8. This contract shall be governed by, and construed in accordance with the laws of the United States of America
